It has come to the notice of the Finance Department during the analysis of salary payments for the financial years 2023-2025 that several employees have been drawing payment of House Rent Allowance (HRA) and City Compensatory Allowance (CCA) incorrectly, in violation of the provisions contained in the respective applicable rules.

Accordingly, the matter has been considered and the Governor is pleased to order that—

- Employees should be posted on the post for which creation has been made by the Government and their salary including allowances should be charged against that post only.
- If Departments 'have posted employees at locations where no sanctioned posts exist and the salary has been drawn for them from elsewhere, in such cases the excess irregular payment of allowances, if any, made to the Government servants by the Department (HOD) shall be recoverable.


**Sub: Review of payment of House Rent Allowance (HRA) and City Compensatory Allowance (CCA) and recovery of Excess Payments.**


