जनगणना कार्य में संलग्न कार्मिकों एवं उनके परिवारों को सामाजिक एवं आर्थिक सुरक्षा की दृष्टि से वित्त विभाग द्वारा जारी अधिसूचना क्रमांक F-12(3)FD/Rules/2014 दिनांक 10.07.2019 के बिन्दु 1 (1)(e) (संलग्न) के प्रावधान अनुसार अनुग्रह अनुदान देय होगी।

अतः उक्त प्रावधानों का स्थानीय स्तर पर समुचित प्रचार—प्रसार किया जावे।

**ORDER**

**Sub: Ex-gratia grant to the family of persons other than State Government servants requisitioned for Election Duty and who dies and grant of ex-gratia to such persons who sustains permanent disability while on election duty.**

The State Government, vide order of even number dated 15.03.2017 has provided guidelines, circumstances and amount of ex-gratia to the family of persons other than State Government servants in case of death / permanent disability on election duty.

The Governor is pleased to revise the amount of ex-gratia in case of death / permanent disability on election duty, as follows :-

(1) In case of death :-

S. No.	Circumstances	Amount of Ex-Gratia grant
1.	In the unfortunate event of death of the official while on election duty.	Rs 20.00 Lac
2.	If the death is caused due to any violent acts of extremist or unsocial elements like, road mines, bomb blasts, armed attacks, etc. of the official while on election duty.	Rs 30.00 Lac


(2) In case of permanent disability :-

S. No.	Kind of Mishaps	Amount of Ex-Gratia grant
1.	Permanent disability like loss of limb, eye sight etc in normal conditions while performing election related duties.	Rs 7.50 Lac
2.	Permanent disability like loss of limb, eye sight etc., while performing election related duties, if caused due to any violent act of extremist or unsocial elements like road mines, bomb blasts, armed attacks etc.	Rs 15.00 Lac

**Note:** (i) This order shall come into effect from 10.03.2019.

(ii) The guidelines, circumstances and other conditions for admissibility of ex-gratia shall remain unchanged.



**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Civil Services (Pension) Rules, 1996, namely:-

**1. Short title and commencement.-** (1) These rules may be called the Rajasthan Civil Services (Pension) (First Amendment) Rules, 2017.

(2) They shall come into force with immediate effect.

**2. Substitution of rule 75.-** The existing rule 75 of the Rajasthan Civil Services (Pension) Rule, 1996, hereinafter referred to as the said rules, shall be substituted by the following, namely:-

**"75. Ex-gratia grant to the family of a Government servant.-**

(1) Subject to the provision of this chapter except as otherwise provided, an ex-gratia grant shall be admissible under sub-rule (2) to the family of a government servant who dies while on duty in one of the following circumstances, namely :-

- (a) in an accident;
- (b) due to injury intentionally inflicted or caused in consequence of the due performance of his/her official duties;
- (c) due to injury intentionally inflicted or caused in consequence of his/her official position;
- (d) by violence attributable to causes relative to his/her service; or
- (e) in connection with special assignments like "Election Duty", "Census work" and/or such other assignments which do not fall within normal duties of the post held by the government servant.

(2) The amount of ex-gratia grant to the family of a government servant who dies in one of the circumstances mentioned in sub-rule (1) shall be as under:-

S. No.	Clause / Rule	Amount of ex-gratia grant
1.	Under clause (a) to (d) of sub-rule (1)	Rs. 20 Lac
2.	Under clause (e) of sub-rule (1),- (i) unfortunate event of death of the official.	Rs. 10 Lac
	(ii) If the death is unfortunately caused due to any violent acts of extremist or unsocial elements like, road mines, bomb blasts, armed attacks, etc.	Rs. 20 Lac

Provided that no extra relief shall be granted from sundry government sources to families of deceased Government servants.

(3) The Ex-gratia grant under sub-rule (2) shall be admissible to the member of family who is entitled for grant of family pension subject to the fulfillment of the following conditions, namely:-

- (a) that the death has either taken place on the spot of the accident or during the course of treatment of injuries caused in such an accident prior to him / her being declared fit by the authorized medical attendant for resumption of duty;
- (b) that a government servant is killed due to his / her official position subject to the condition that there is a direct connection between occurrence of death and his / her official position;
- (c) that it is clearly established on record and certified in the sanction that the death of the government servant has taken place while on duty and this fact is not subject to any dispute; and

Explanation: (i) an accident means sudden and unavoidable mishap while government servant was on duty ;

(ii) in the case of death of a government servant while on duty by violence attributable to service, means death as a result of encounter with criminals or in the course of confrontation with mob or crowds of an unlawful assembly during agitation, riot or civil commotion or communal disturbances etc;

(iii) the death of a government servant in the circumstances other than that mentioned in sub-rule (1) shall not be treated as death on duty for this purpose.

(4) An application for grant of ex-gratia shall be submitted to the competent authority in Form 17 appended to these rules within a period of one year from the date of death.

(5) The competent authorities to sanction ex-gratia grant under sub-rule (2) shall be as under :-

S. No.	Under Clause	Competent Authorities
1.	Under clause (a) to (d) of sub-rule (1)	Head of the Department
2.	Under clause (e) of sub-rule (1)	District Collector/ District Election Officer



(6) Where a government servant sustains permanent disability, like loss of limb, eye sight etc., in connection with election related duties amount of Ex-gratia grant shall be as follows:-

S. No.	Kind of Mishaps	Amount of ex-gratia grant
1.	Permanent disability like loss of limb, eye sight etc., in normal conditions while performing election related duties.	Rs. 5 Lac
2.	Permanent disability like loss of limb, eye sight etc., while performing election related duties, if caused due to any violent act of extremist or unsocial elements like road mines, bomb blasts, armed attacks etc.	Rs. 10 Lac

(7) The amount of ex-gratia grant specified under sub-rule (6) shall be granted to the government servant by the District Election Officer on furnishing an application in Form 17A appended to these rules by the concerned government servant through his / her Head of Office within a period of one year from the date of permanent disability.

Explanation : "Election duty" and "Duty" for the purpose, this shall mean as explained in FD order No. F.1(5)FD/Rules/2010 dated 14.12.2012 under rule 7(8) of Rajasthan Service Rules.

**3. Amendment of rule 76.-** The existing proviso to rule 76 of the said rules shall be substituted by the following, namely :-

"Provided that no extra relief shall be granted from sundry government sources to families of deceased Government servants."

**4. Deletion of rule 76A.-** The existing rule 76A of the said rules shall be deleted.

**5. Amendment of rule 105.-** The existing sub-rule (f) of rule 105 of the said rules, shall be deleted.

**6. Amendment of rule 106.-** In rule 106 of the said rules,-

- (i) in sub-rule (a) and (b) of rule 106 of the said rules, for the existing expression "Director General of Police/Director, Civil Defence & Commandant General, Home Guards", the expression "Director General of Police / Director General, Home Guards / Director, Civil Defence" shall be substituted; and
- (ii) the existing sub-rule (f) shall be deleted.

**7. Substitution of Form 17.-** The existing Form 17 appended to these rules, shall be substituted by the following, namely:-

- (b) Attack by poachers on Forestry personnel.
